3. That all the signatures were affixed in his/her presence;
4. That he/she believes them to be genuine signatures of the person whose names they purport to be; and
5. That each signer had the opportunity before signing to read the full text of Ordinance No. 1751.

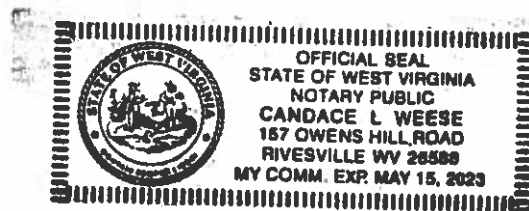
